Recurring Gifts Enhance Care & Experience

Nihita and Siddharth Patel have harnessed the power of generous, recurring giving to ensure the highest-quality, compassionate care while expanding opportunities for the abilities of us all.

In 2014, the Patel's daughter, Ashini, joined the Seven Hills Worcester Day Habilitation program after transitioning out of high school. The program's director, Cathi Joseph, recalls the family's enthusiasm at the transition-plan meeting. Ashini attends the program daily and enjoys socializing with her peers. She engages in various educational and recreational programming on site and in the community.

Over the past decade, the Patels have become familiar with their daughter's routine, program environment, and staff—many of whom have been with the program for many years. As a result, the Patels have readily responded to identified needs as they arise with regular, generous donations totaling more than \$60,000.

The Patel's support has resulted in significant enhancements to the Worcester Day Habilitation program space, including the installation of a state-of-the-art sensory room and six-foot saltwater fish tank—not to be missed by everyone who enters the building. Surrounded by seating, the colorful tank display and its mesmerizing movement within, provides a place to quiet, reflect, and reset for participants and their companions.

"The Patels are so in tune with Ashini's ability to thrive in her environment and have an eye for enhancements," Cathi Joseph said. "They are graciously forthcoming with generous support of new technology, amenities, and programming that benefit our work and enrich the lives of our participants."

Finding, nurturing, and strengthening the right connections can secure the comfort and contentment of a child or loved one with a disability. In finding Seven Hills, the Patels have personally secured the daily promise of friendship, fellowship, and a brighter future for Ashini.

Furthermore, the Patel's generosity has created a lasting impact for Ashini's peers and all of the participants who attend the Worcester Day Habilitation program each year.

Ensuring Successful College Access for Students

Seven Hills Foundation is a longstanding proponent of advancing education opportunities for students with low-income backgrounds. The majority of these students who make the leap from a high school diploma to a college degree also make the leap from a lifetime of insecurity to one filled with unlimited potential.

Seven Hills offers two College Access programs based in Worcester: Bruce Wells Scholars Upward Bound (BWSUB) and Dynamy John S. Laws Youth Academy (DJLYA). BWSUB is a federally funded TRIO program in partnership with Clark University and Worcester Public Schools. DJLYA is a privately funded college success and leadership program. These rigorous pathways to higher education require exceptional effort and commitment to succeed.

The demand is equally impressed upon the staff and network of partners, resources, and mentors, like Laurie and Tom Peltier. For more than ten years, the Peltiers have aced the trifecta of talent, energy, and innovation.

Laurie Peltier, an expert in financial aid, has volunteered countless hours assisting students and their families with the process of Free Application for Federal Student Aid (FAFSA). Applying for financial aid confounds even the most astute applicant; Laurie's expertise is invaluable and instrumental to the optimum degree of success.

Over the past decade, Tom Peltier has mastered the art of mentoring, orchestrating strategic connections with the finesse of a seasoned conductor. Students engage in real-world experiences to broaden their career horizons. Tom even leverages his own vibrant professional network to expand the program's mentor pool.

Separately, Laurie and Tom have used their unique talents to benefit the College Access scholars. Together, they are unstoppable. Due to a staff shortage this year, the Peltiers stepped in to lead "internship week," managing outreach and the tracking of all 45 sites to ensure success.

The Ongoing Impact of Legacy Giving

Over the past twenty years, Eileen and Jerry Kramer have established a legacy of generous giving to support Seven Hills Foundation & Affiliates. This legacy includes more than \$138,000 in donations that have impacted Seven Hills initiatives such as capital campaigns, the New Beginnings and Lori Lajoie golf tournaments, holiday appeals, anniversary galas, and memorial giving.

Personally significant are the capital improvements to the Seven Hills Community Services (SHCS) residential program. For years, the Kramers' two sons have been supported by SHCS and its exceptional staff. In particular, Karen Reynolds devoted her entire career to the Seven Hills mission, most recently as an assistant vice president, ensuring SHCS residents received optimum care, comfort, safety, and community experiences.

In 2024, Reynolds announced her retirement after 45 years of service to Seven Hills—and, in part, to the Kramers' sons. At Karen's retirement party, Eileen and Jerry announced their launch of the "Karen Reynolds Out & About Fund," with a \$5,000 initial donation to honor Karen's legacy of caregiving. The fund is designated to provide community outings to the residents in the homes of Seven Hills Community Services and NeuroCare.

The Kramers expressed their admiration for Karen's leadership and appreciation for her dedication to the people she supported. Jerry noted that, in 2022, one of their sons experienced a medical emergency and needed surgery. Karen met the Kramers at the hospital and waited with them during the operation. When they learned their son had to remain hospitalized for a month, Karen arranged to have SHCS staff rotate their shifts to be with him around the clock. Jerry noted that Karen leads by example, never wavering on her respect of the people she supports.

"We are proud to start Karen's Out & About Fund and will contribute each year to honor Karen," Jerry said.

Leading by example, Jerry and Eileen observe and respond to the needs of participants and families. Seven Hills is truly grateful for their commitment to legacy giving and its lasting impact. May their example inspire others to create a legacy of giving and empower the abilities of us all.

Planned Giving Provides Peace of Mind

As parents of two daughters with disabilities, longtime Worcester residents Frances and Jack Callan started advocating for children with developmental disabilities in the early 1950s. The couple became well-known leaders in the disability community, spearheading inclusion and demand for high-quality services and opportunities for people with disabilities in Central Massachusetts. They eventually co-founded the organization that grew into Seven Hills Foundation.

As part of their estate planning, the Callans set up a trust for their daughter, Kathleen “Kathy” Callan, who lived in a Seven Hills group home in Worcester. Seven Hills supported Kathy from 1993 until her passing in 2021, building a legacy of trust with the family. Kathy’s caregivers ensured that she was able to access the things she loved most in life, including travel, boating, gardening, and her beloved cats.

Frances and Jack recognized that, despite her disabilities, Kathy exuded a free spirit and determination to live her life to the fullest. She understood she had limits, but she pushed those limits to the best of her abilities. The family thrived on adventure with Kathy usually in the lead. The Callans embraced her enthusiasm and wanted to ensure it endured beyond their lifetimes. Following Kathy’s passing, Seven Hills received its first gift from The Callan Trust.

Exceptional gifts such as bequests and planned giving, are meaningful contributions to Seven Hills’ efficiency in answering the Call to Care for the most vulnerable members of our communities while safeguarding our donors’ legacies.

Through our daily efforts, Seven Hills upholds the values and priorities of the Callan family by fulfilling our mission to promote and encourage the empowerment of people with significant challenges so that each may pursue their highest possible degree of personal well-being and independence.
